

- Circa 1820, two-story, stone house with a frame bank barn and a root cellar.
- Status: Potentially eligible for the National Register.
- N-317 Oberod Gate House
6020 Kennett Pike
Tax Parcel: 07-001.00-021
- Circa 1850, three-story, stuccoed house with hipped roof appears to have been remodeled to serve as a gate house to Oberod estate.
- Status: Potentially eligible for the National Register as an element of Oberod estate (see N-315 and N-7694).
- N-333 Henry Clay Village Historic District
Roughly bounded by Breck's Lane, Kennett Pike, Rising Sun Lane, and the Brandywine River.

Henry Clay Village is a rare example of an intact early industrial village. The district contains approximately 80 buildings of note, including workers' dwellings, millowners' homes, and some commercial and community buildings. The mill owners built many of the houses for their workers, but Henry Clay Village was not a planned company town. Initially, textile mills were the primary employers, but later the duPont black powder mills employed the majority of workers.

Status: Listed in the National Register.

The Brandywine Powder Mills District was the site of continuous industrial use from the late eighteenth century through 1921, and is significant to the industrial and technological history of the state and the nation. Beginning as a series of self-contained mill communities, it evolved into the largest manufactory of black gun powder on the North American continent. The explosives produced contributed to every American war effort from the War of 1812 through World War I and to peace time projects such as the building of the Erie Canal and opening of the coal fields. The site is now operated by Hagley Museum and is open to the public.

Status: National Historic Landmark and National Register (boundaries for each designation are different). Some elements of the district have also been recorded for the Historic American Engineering Record and the Historic American Buildings Survey

(Birkenhead Mill, site #DE-2; and Charles I. duPont House, site #DE-66).

Lower Louviers, a federal-style house dating to 1811, was built for Victor duPont, who operated a woolen mill on the Brandywine River. Included on the site is Chicken Alley, a row of nineteenth century dwellings that housed some of the mill workers.

The Rockland Historic District is one of the earliest and longest functioning mill sites on the Brandywine River. John Gregg and Adam Kirk established their saw and grist mill in 1724 and Jonathan Strange built a fulling mill in 1733. After the river was dammed in 1794, William Young built a paper mill, and later converted to the milling of cotton and wool. In 1860, the firm of Jessup and Moore bought Young's holdings and expanded its paper making business. Paper milling continued at Rockland past the middle of the twentieth century. The existing mill owner's houses, workers' dwellings, and mill buildings represent the late eighteenth and nineteenth century operations.

Status: Listed in the National Register. Two sites within the district have been recorded for the Historic American Buildings Survey (site #DE-63 and DE-66).

Hagley Museum Property

Tax Parcel: 07-027.00-032

Built in 1817, this one-story, stone schoolhouse was a pioneering effort by the mill owners along the Brandywine River to provide a basic education for the children of their workers. Classes in reading, writing, and arithmetic were held on Sunday, that being the only free day of the week. Some non-denominational religion was also taught.

Status: Individually listed in the National Register; also included within the boundaries of the Eleutherian Mills National Historic Landmark District (see N-339).

Upper Louviers

South side of Black Gates Road, southwest of Rockland Road
Tax Parcel: 06-109.00-001

Upper Louviers was one of the duPont family's early homes on the Brandywine. The house was built early in the nineteenth century but was expanded several times. Ultimately, the stuccoed stone and brick building reached three stories and displayed Greek Revival style elements. Its most well-known occupant was Admiral Samuel Francis duPont of Civil War fame, and for whom DuPont Circle in Washington, D.C. is named. The estate also contains a pair of gate houses (see N-1372).

Status: The estate was listed in the National Register. Upper Louviers has been demolished, but the gate houses remain and are still considered to be listed in the Register. The property was also recorded for the Historic American Buildings Survey (site #DE-62).

Walker's Mill and Bank

East Bank of the Brandywine River at Rising Sun Lane
Tax Parcel: 06-126.00-001

Built in 1813, Walker's Mill is a stone structure with a brick bell tower. It initially housed cotton spinning machinery, but was refitted with looms in 1848. Walker's Bank, also dating to 1813, is a connected row of stone dwellings that housed the mill workers.

Status: Individually listed in the National Register and also included in the Eleutherian Mills National Historic Landmark District (see N-339). Recorded for the Historic American Buildings Survey (site #DE-65 and DE-67).

The estate of Irene duPont contains the stone mansion he had built in 1923, stables, gardens, and water towers. The architect was Albert Spahr.
